A MESSAGE FROM THE FOUNDATION EXECUTIVE DIRECTOR

The Foundation has been hard at work supporting rural healthcare through Beartooth Billings Clinic. Donor dollars are strategically distributed or invested per donor request each year to benefit a variety of patient care departments, community health programs, and advancements in healthcare technology.

Through donor support, the Foundation has funded the purchase of a portable ultrasound machine now being used in the clinic, emergency and physical therapy departments. Nursing staff and patients are benefitting from new vital sign monitors as well as work stations on wheels. These pieces of equipment benefit the patients in the clinic, the emergency department as well as inpatient care by allowing more face to face interaction and less duplication of documentation.

In partnership with Red Lodge Mountain, our trauma services team continues to educate students from 18 schools about safe skiing and the importance of using helmets on the ski hill. Over 100 helmets are purchased each year through this program and approximately 5-10 are provided free of charge for those in need. The Beartooth Children's Center receives funds from donors through the Foundation to support operations, classroom supplies, technology and special events. The Dr. James and Juanita Kane Scholarship fund is fulfilling the mission of Dr. Kane who wished to see students and staff from Carbon County receive an education and return to rural areas to provide care to the community he held dear. Grant writing is a large part of the work of the Foundation; we secure funds to purchase new equipment like the recent upgrade to a Toshiba Aquilion One CT scanner and to support new programs which included the hiring of a Registered Nurse Navigator who coordinates smooth patient transition in hospital admits, discharge planning, and case management.

Our hearts and minds are connected to the patients we serve and the staff who care for them. The Foundation Board and our dedicated community of donors work with me to fund the future of healthcare, and I thank each of you for your support.





Community Benefit

CARING FOR OUR COMMUNITY

Many of the healthcare services we provide occur outside the boundaries of the traditional clinic or hospital setting. Throughout the year, our staff can be found providing Sports Medicine to school athletes and professional rodeo competitors. We promote snowsports safety through our "Slide Safe + Dress Smart" program. Expecting parents receive Childbirth Education free of charge through our Public Health contract. Free Health Insurance Marketplace Certified Navigator assistance is available. This type of care is known broadly as "Community Benefit Care," an umbrella term that encompasses a number of programs outlined here and included in the chart, which are offered at no or minimal cost to the patient.

Financial Assistance, in the form of free or discounted healthcare services, is given to a large number of patients at our facility. We absorb the cost of care provided to medically indigent patients. We provide care to all who come through our doors, regardless of their financial situation.

Community Building Activities are designed to protect or improve the community's health or safety. This category includes a number of programs, such as participation in the Local Emergency Planning Committee, operating the Beartooth Children's Center, financial sponsorship of a variety of health enhancing events, disaster readiness and Public Health emergency activities.



Bad Debt, Medicare & Collection Practices encompass patients who choose not to pay for medical services received here, although they do not fit into the medically indigent category. Also included in this category are any Medicare shortfalls in reimbursement payment for services provided to Medicare patients.

Community Health Improvement activities are those subsidized by Beartooth Billings Clinic for the express

purpose of improving community health. These services do not generate any patient revenue, although there may be a nominal fee collected. Activities in this bracket include our Annual Health Fair, Nutrition Education Outreach, Student Athlete Sports Physicals,



discounted prescription drug program, plus Childbirth Education Classes.

Community Benefit Operations consist of activities associated with our Community Health Needs Assessment, as well as activities associated with fundraising or grant writing.



Health Professions Education involves educational programs open to all area health care professionals and medical students.

Subsidized Health Services for this report are clinical services we provide at a financial loss, but which meet an identified community need.

OUTPATIENT SURGERY NOW AVAILABLE AT BEARTOOTH

Patients who desire certain outpatient surgical procedures close to home now have the option to have the surgery performed at Beartooth. Surgeons choose to perform certain elective, minimally invasive, procedures here because they like the spacious and sophisticated operating room, the expertise of the surgical team, and the fact that their patients don't have to travel 60 miles before – and after – a procedure, especially when driving conditions are poor. Our first outpatient surgical procedure, the removal of a mass, was performed by John Pender, MD, Billings Clinic General Surgeon.

MYMEDICALRECORD OFFERS ONLINE ACCESS

First introduced in 2015, patients now have the ability to view their own medical records and health info online 24/7. The accessibility of one's medical info, through what is called "My Medical Record,"

is a result of the Health Information Technology for Economic and Clinical Health Act (HITECH Act). The use of electronic health records (EHR) is designed to improve quality, safety, efficiency, and reduce health disparities; to engage patients and family in their own health care;





CUTTING EDGE CT SCANNER FROM THE HELMSLEY CHARITABLE TRUST

Patients now have access to the latest computed tomography (CT) diagnostic technology made possible through a grant from The Leona M. and Harry B. Helmsley Charitable Trust's Rural Healthcare Program. 
